I care that they are struggling and trying to make ends meet. I care that they are forced into homelessness because they can no longer afford to live in their home. I care that their family and friends abandoned them when all they wanted was a gift of their time. I guess being widowed is a topic that no one likes to discuss. I have not received any responses. No one wants to print the stories that I want to tell. Below is a letter to the Observer Reporter Editor I wrote on August 17, 2024 that was never published. If you care, please let me know. I would love to hear from you.

## Letter to the Editor

Once again Washington County released their notice of properties for delinquent taxes. 30 pages of property listings and this is just Washington County. Are the property owners widowed or seniors? Does anyone care? I do! Our elected officials don't seem to care about us losing our homes over a tax we can no longer afford to pay. What happened to property tax reform? My opinion, it was just a campaign promise to get elected but would never be fulfilled. I have written letters to Bartolotta and Ortitay. I even put together a presentation of why we need property tax reform and met with Ortitay back in May 2023. I got the impression that he didn't care about what I had to say. I have written to both Bartolotta and Ortitay since then but never received a response back. I wrote to Governor Shapiro in July 2023. You can read my letter to him on the home page of my website www.emailstoheaven.org. I have written another letter to him since then but never received a response to either of my letters. Within my nonprofit I am trying to make a change for our widowed neighbors and my biggest issue is school property taxes. Ortitay and Shapiro talked about the increase in the property tax/rent rebate program and how it was going to make Pennsylvania a better place to live. Most of us got \$130 out of the \$350 increase. But Canon Mac raised the school taxes "again" and the \$130 doesn't even cover the increase we now have to pay. Our elected officials need to start thinking outside the box on funding Pennsylvania schools because property taxes isn't the answer. This expense is too much for property owners to handle alone and no one should have to lose their home, especially for those of us who receive "no service" for this tax. Think about this the next time you vote. These 3 have done nothing to help our widowed property owners or seniors with this tax burden. AARP wrote an article on homelessness growing among older Americans starting now at age 55 with a dramatic increase where they will be unable to secure housing over the coming decade. I guess Bartolotta, Ortitay and Shapiro would rather see us homeless than to find a solution to this tax problem. Shame on them!

# Definition of Widowed

Since 2017 I have been trying to get the attention of our elected officials to start a conversation on how the IRS discriminates against those of us who are widowed without children living with us. We cannot claim ourselves as widowed for tax filing purposes. We have to claim ourselves as single. To the right is the definition of a person who is wid-

Below is the IRS's definition of widowed. Before 2022 they called it "Qualifying Widow(er) - in 2022 they changed the filing status name to Qualifying Surviving Spouse. The definition stayed the same.

I am not sure what having a child living with you decides whether or not you can claim yourself as widowed/surviving spouse, because the only qualification that I need to call myself a widow is that my husband is now deceased. I have sent letters to President Trump twice, Senator Toomey once, President Biden once, and recently to Lara Trump at the Trump NC and the RNC Headquarters. I am hoping for a response, if not, I century supplanting "widow" with reference to men. will keep trying.

# IRS 's Definition of Widowed

### Qualifying Widow(er)

You can check the "Qualifying widow(er)" box at the top of Form 1040 or 1040-SR and use joint return tax rates for 2021 if all of the following apply.

- 1. Your spouse died in 2019 or 2020 and you didn't remarry before the end of 2021.
- 2. You have a child or stepchild (not a foster child) whom you can claim as a dependent or could claim as a dependent except that, for 2021:
- a. The child had gross income of \$4,300 or more.
  - b. The child filed a joint return, or
- c. You could be claimed as a dependent on someone else's return.

Filing status name changed to qualifying surviving spouse. The filing status qualifying widow(er) is now called qualifying surviving spouse. The rules for the filing status have not changed. The same rules that applied for qualifying widow(er) apply to qualifying surviving spouse. See Qualifying surviving spouse,
